

2015 My LA2050 Challenge Grants Challenge OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. NO ENTRY FEE.

COMMON TERMS USED IN THESE RULES:

These are the official rules ("Official Rules") that govern how the My LA2050 Challenge will operate ("Contest"). In these rules, "we," "our," and "us" refer to the Goldhirsh Foundation and GOOD Worldwide Inc ("GOOD"), the co-Sponsors of this Contest. "You" refers to the authorized representative of an eligible Organization, as described below.

BY PARTICIPATING IN THE CONTEST, YOU BECOME A PARTICIPANT AND AGREE TO GOOD'S TERMS AND PRIVACY POLICY AVAILABLE AT WWW.GOOD.IS (THE "SITE"). IN ADDITION, YOU UNDERSTAND AND AGREE THAT YOUR APPLICATION AND THE PERSONAL INFORMATION COLLECTED FROM YOU MAY BE STORED BY THE GOLDBHIRSH FOUNDATION AND GOOD AND THAT YOU MAY BE CONTACTED IN CONNECTION WITH THIS CONTEST OR SIMILAR CONTESTS BY THE GOLDBHIRSH FOUNDATION, GOOD OR ANY OTHER ENTITY INVOLVED IN THE CONTEST. PARTICIPATION IN THE CONTEST CONSTITUTES YOUR FULL AND UNCONDITIONAL AGREEMENT TO AND ACCEPTANCE OF THESE OFFICIAL RULES AND REGULATIONS ("OFFICIAL RULES").

1. Contest Description

The My LA2050 Grants Challenge (the "Contest") is a two-part online grant contest that will involve both judging by the Goldhirsh Foundation and voting by the public to help determine the Contest winners. In order to participate in the Contest, applicants must submit ideas, concepts, images, designs, and/or other materials and information, as described in detail below (collectively, the "Application"), to the Goldhirsh Foundation and GOOD in accordance with the terms and conditions specified herein (such applicants become "Participants").

The object of this Contest is to select 10 Los Angeles County based projects, impacting one of the five LA2050 Goals (the "Categories" as described in detail in section 8): LA is the best place to play, LA is the best place to create, LA is the best place to learn, LA is the best place to connect, and LA is the best place to live. All eligible Applications received will be judged using the criteria described below to determine which Applications will be posted on www.la2050.org/challenge (myla2050learn2015.maker.good.is, myla2050create2015.maker.good.is, myla2050connect2015.maker.good.is, myla2050play2015.maker.good.is, myla2050live2015.maker.good.is) (the "Contest Site") for online voting. Of the ten (10) approved Applications which receive the most online votes in their respective Category, the Goldhirsh Foundation will select one Application to receive a \$100,000 grant to implement their proposal (five total). Additionally, five (5) approved Applications (one in each Category) will be selected by the Goldhirsh Foundation to receive a \$100,000 grant to implement their proposal, irrespective of their standing in the public vote. Notwithstanding the foregoing, the board of directors of the Goldhirsh Foundation retains final control and authority regarding approval of such grants.

2. Eligibility

The Contest is open to non-profit organizations, for-profit business organizations, and government agencies that operate in the State of California (each an "Authorized Organization"); individuals may not enter in their individual capacity. Any person submitting an Application on behalf of an eligible organization must have the express permission of that organization to enter this Contest and bind the organization to these Official Rules. All voters in the Contest must be residents of the fifty United States and the District of Columbia who are eighteen (18) years of age or older as of the beginning of the Contest Period (defined below). Employees of GOOD or the Goldhirsh Foundation; their respective subsidiaries; their respective advertising, promotion, fulfillment, or other coordinating agencies; (collectively, the "Contest Entities") and their respective immediate family members and persons living in their same household, whether related or not; are not eligible to submit an Application, become a Participant, or vote in the Contest. Although the Goldhirsh Foundation and GOOD may use mechanisms to verify the eligibility of

Participants, voters, and Winners (defined below), the Goldhirsh Foundation and GOOD is under no obligation to verify the eligibility of any particular Participant, voter, or Winner or to take any corrective action as a result of such verification of eligibility.

Technically there can be multiple entries from the same organization, so long as the project ideas are unique. The Goldhirsh Foundation, in its sole and absolute discretion, will make the final determination as to which Participants and Applications are accepted and are eligible to take part in the Contest, to be considered for inclusion in the Voting Period and on the Site, and/or to receive any Grant.

Organizations who won funding in the 2013 and 2014 My LA2050 Grants Challenge are eligible to apply for the 2015 My LA2050 Grants Challenge..

3. Contest Period

The opportunity to participate in the Contest begins at 12:00 PM noon PT on Tuesday, September 8th, 2015 (the first date and time Applications may be submitted) and ends at 12:00 PM noon PT on Tuesday, October 6th, 2015 (the last date and time the Winner [defined below] may be selected) (the "Contest Period"). As set forth below, the Contest Period includes one period when Applications can be submitted (the "Application Period"), followed by a second period when members of the general public can vote on the entries (the "Voting Period"), and finally followed by a third period when the Goldhirsh Foundation will select one (1) approved Application in each of the five (5) Categories, to be selected from the ten (10) approved Applications which receive the most valid online votes in their respective Category, and select an additional five (5) approved Applications (one per Category) based on evaluations of the Applications to be the "Winners" (the "Judging Period").

The Application Period begins at 12:00 PM noon PT on Tuesday, September 8th, 2015 and ends at 12:00 PM noon PT on Tuesday, October 6th, 2015. The Voting Period begins at 12:00 PM noon PT on Tuesday, October 20th, 2015 and ends at 12:00 PM noon PT on Tuesday, November 3rd, 2015. The Judging Period begins at 12:00 PM noon PT on Wednesday, November 4th, 2015 and ends at 12:00 PM noon PT on Tuesday, December 8th, 2015.

4. Grants

Subject to terms and conditions described herein, all valid Entries that meet the Contest criteria will enter the Voting Period.

There will be ten (10) Winners in total, and two (2) Winners per Category. Of the ten (10) approved Applications which receive the most online votes in their Category, the Goldhirsh Foundation will select one (1) approved Application to be the "Winner" in each Category, five (5) total, based on evaluations of the Applications. The Goldhirsh Foundation will select an additional one (1) approved Application to be the "Winner" in each Category, based on evaluations of their Applications. The Category Winners, subject to the terms and conditions described herein, will be awarded the following: one (1) grant in the amount of one hundred thousand dollars (\$100,000) (the "Grant").

The Winners, subject to the terms and conditions described herein, will be awarded the following: one (1) grant in the amount of one hundred thousand dollars (\$100,000) (the "Grant").

Notwithstanding the foregoing, the board of directors of the Goldhirsh Foundation retains final control and authority regarding approval of such grants.

The Winner(s) will be announced by the Goldhirsh Foundation and GOOD on Tuesday, December 8th, 2015. Failure to respond to a Finalist or Winner notification within the specified time period or to follow the terms and conditions of these Official Rules may cause the Goldhirsh Foundation and GOOD to disqualify a Finalist or Winner (with the Finalist or Winner forfeiting any eligibility for a Grant). In such case, the Goldhirsh Foundation may select an alternate Winner from the remaining Finalists.

5. How to Submit an Application

During the Application Period, go to the Site and follow the directions to submit an Application to become a Participant in the Contest. Your Application must contain text that describes a project to be carried out for charitable, community, or educational purposes by Participant and may contain a link to a YouTube video or a high resolution photograph.

To be eligible for consideration for posting to the Site for voting, an Application must (i) be submitted through the Site by the end of the Application Period; and (ii) comply with these Official Rules.

All Applications may be reviewed for compliance with these Official Rules; however, such review does not relieve Participant from responsibility for compliance with these Official Rules, and Participant will have sole liability for all third-party claims relating to or regarding the content of the Application. Applications that do not comply with these Official Rules or that otherwise contain prohibited or inappropriate content as determined by the Goldhirsh Foundation and GOOD in their sole and absolute discretion may be disqualified at any time without notice.

The Goldhirsh Foundation and LA2050 may showcase submissions on social media channels as they are accepted up until voting begins (between Tuesday, September 8th, 2015 and Monday, October 19th, 2015). Due to limited social media calendar availability, the Goldhirsh Foundation cannot guarantee to showcase any particular submission.

6. Application Content Guidelines

Applications MUST:

- Be in English;
- describe a project that would be implemented in Los Angeles County;
- describe a project that will impact one of the five (5) LA2050 Goals (the “Categories”) as described in detail in section eight (8) below;
- be capable of being activated with the amount awarded in the Grant;
- be capable of being implemented within 12 months of Grant award; and
- provide a level of detail sufficient to show each of the specific activities to be carried out by the Applicant and others, if any, necessary to achieve the principal goal(s) of the project.

Applications MUST NOT:

- Suggest legalization of any illegal drugs/activity, prostitution or pornography, or other illegal activities or goods;
- attempt to influence legislation within the meaning of Internal Revenue Code Section 501(h) or to influence the outcome of any specific election, or overthrow any government;
- be inconsistent with these Official Rules;
- suggest or encourage the taking up of arms against any person, government, or entity;
- discriminate against, disparage, or denigrate on the basis of race, ancestry, place of origin, color, ethnic origin, citizenship, creed, sex, sexual orientation, age, record of offenses, marital status, family status, physical or mental disability, language, or any other ground prohibited by applicable legislation;
- disparage or denigrate a product, service, person, company, or organization including, but not limited to, GOOD, the Goldhirsh Foundation, or any other Contest Entity;
- encourage the cessation of or act to negatively impact a business or enterprise;
- promote alcohol, illegal drugs or activity, tobacco, firearms/weapons, prostitution, or pornography;
- contain any profanities, be overtly sexual, suggest an intent to abuse, or contain suggestions of violence;
- involve religious advocacy or proselytizing, defined as acts and intentions to advance a religious denomination or expand membership or encourage conversion;
- involve political advocacy such as acts and intentions to advance a particular political party, candidate or to support any particular party, candidate and/or cause, or to expand membership or to encourage membership for a particular political party, candidate or lobbying effort or voter registration drive;

feature or reference any third party;

- describe a project that directly or principally benefits the Participant or any other specific individual (as opposed to the identified community as a whole);
- describe a project with a purpose of re-granting potential Grant funds to another organization(s);
- feature any third-party commercial products and/or company trademarks, logos, brands, or endorsements (including but not limited to third-party logos on street scenes, panoramic views, vehicle license plates, or clothing, such as t-shirts or hats); an Application may contain the name and trademark of an organization to be benefited by a Grant, provided prior permission has been obtained from such organization;
- use individuals' names, in whole or in part, without permission; or
- contain materials embodying the names, likenesses, photographs, or other identifying elements of any person, living or dead, without permission.

Applications must: (i) be original and of Participant's own creation, and (ii) not violate the intellectual property or proprietary rights of other parties. Once submitted, an Application will not be returned. The Goldhirsh Foundation and GOOD may, in their sole and absolute discretion, reject, refuse, remove, delete, and/or disqualify or disallow any Application that the Goldhirsh Foundation and/or GOOD, in their sole and absolute discretion, deems inappropriate or otherwise non-compliant with these Official Rules. If the Goldhirsh Foundation, GOOD or any Contest Entity, at any time during the Contest Period, receives a complaint (including but not limited to a cease-and desist letter, general letter of complaint, etc.) alleging intellectual property infringement in an Application, the Goldhirsh Foundation and/or GOOD may, in their sole and absolute discretion, remove such Application from the Site and disqualify the Application without prior notice to Participant.

7. Application Selection

During the Judging Period, the Goldhirsh Foundation (the "Judges"), in their sole and absolute discretion, will select one (1) Application in each of the five (5) Categories, to be selected from the ten (10) Applications which receive the most valid online votes in their respective Category to be the "Winner" based on evaluations of the Applications. The Goldhirsh Foundation (the "Judges") will select five (5) additional Applications based on evaluations of their Applications. There will be ten (10) Winners total.

The Applications will be selected based upon the projected impact on one or more of the five (5) Categories, feasibility of implementation, creativity and innovation of submitted responses, as well as adherence to these Official Rules and any other criteria the Goldhirsh Foundation may establish. All Contest Selections will be posted to the Site for voting at the start of the Voting Period. The Goldhirsh Foundation, in its sole and absolute discretion, will make the final determination as to which Participants and Applications are accepted and are eligible to take part in the Contest, to be considered for inclusion in the Voting Period and on the Site, and/or to receive any Grant.

8. Categories

Projects will impact one of the five (5) LA2050 Goals (the "Categories") as described in detail below, *including but not limited to* the following goals and metrics:

LA IS THE BEST PLACE TO LEARN

Our region offers opportunities for lifelong learning, allowing all residents to contribute their skills, talents, and abilities to society. By 2050, all Los Angeles students will have access to early education programs, every high school student will graduate and be college and career ready, and all parents will be engaged and empowered to direct their children's learning. LA will capitalize on its concentration of higher education facilities to foster new businesses, advance research, and spur innovation.

Metrics:

2. Percent of community college students completing a certificate, degree, or transfer-related program in six years
3. Youth unemployment and underemployment
4. District-wide graduation rates

5. HS student proficiency in English & Language Arts and Math

8. Student education pipeline (an integrated network of pre-schools, K-12 institutions, and higher education systems that prepares students for seamless transitions between high school, higher education institutions, and the workforce -- similar to the Commit! Partnership dashboard) (Dream Metric)
9. Suspension and expulsion rates (Dream Metric)
10. Truancy rates in elementary and middle schools (Dream Metric)
11. Students perceived sense of safety at and on the way to school (Dream Metric)

LA IS THE BEST PLACE TO CREATE

Our region empowers its residents to harness their creativity by fostering entrepreneurship, cultural diversity, and inclusivity. In 2050, Los Angeles will continue to play host to the largest concentration of working artists in the nation and provide support to maintain (and build) its robust collection of arts establishments. It will lead the nation in manufacturing and become an international leader in technology and innovation. Our region will be a center for entrepreneurial activity that creates jobs and generates wealth for a diverse, flexible, and talented workforce. LA's business community will reflect the diversity of our region, enhancing our international business opportunities.

12. Recruiting and retention rates for local higher education institutions (Dream Metric)
13. Percentage of graduates from local higher education institutions that remain in LA County 5 years after graduating (Dream Metric)
14. Unemployment rates (and opportunities) for the formerly incarcerated (Dream Metric)

LA IS THE BEST PLACE TO PLAY

Our region is a place where people of all ages have easy access to clean, safe, and sustainable venues to enjoy the natural environment, arts and cultural resources, and local beaches, waterways, and open space. In 2050, people of all ages will enjoy safe homes, safe neighborhoods, and safe places to play. Every neighborhood will provide its residents with vibrant park space, every child will have access to afterschool enrichment programs, and residents will love their neighborhoods.

Metrics:

1. Access to open space and park facilities
2. Number of children enrolled in afterschool programs
3. Per capita crime rates
4. Percentage of residents that feel safe in their neighborhoods
5. Attendance at major league sporting events
6. Residents within ¼ mile of a park (Dream Metric)
7. Number of residents with easy access to a "vibrant" park (Dream Metric)
8. Number of parks with intergenerational play opportunities (Dream Metric)
9. Number (and quality) of informal spaces for play (Dream Metric)

LA IS THE BEST PLACE TO CONNECT

Our region is a place where every resident has the opportunity to engage and interact with other Angelenos and are empowered to contribute meaningfully in civic processes. In 2050, Los Angeles will be the most civically engaged region in the U.S., with multiple online and offline platforms for residents to voice their opinions and influence elected officials, decision-makers, and local government. Our region's voting rates and volunteerism will lead the nation, and an expanded network of transportation options will facilitate the easy flow of people and ideas.

LA IS THE HEALTHIEST PLACE TO LIVE

Our region's residents have the economic means and cultural capital to lead active, healthy lives, and everyone benefits from a sustainable environment.

In 2050, Los Angeles will have the nation's lowest obesity rates and every neighborhood will have access to healthy, affordable food. Every family will be able to afford quality health care and housing. And no families will face environmental health hazards because of where they live or how much money they make.

Metrics:

1. Access to healthy food
2. Healthcare access
3. Exposure to air toxins
4. Number of households below the self-sufficiency index
5. Percent of imported water
6. Obesity rates
7. Housing affordability
8. Rates of homelessness
9. Walk/bike/transit score
10. Acres and miles of polluted waterways
11. Rates of mental illness
12. Prevalence of adverse childhood experiences (Dream Metric)
13. Percentage of LA communities that are resilient (Dream Metric)
14. Percentage of residents receiving coordinated healthcare services (Dream Metric)
15. Percentage of tree canopy cover (Dream Metric)

9. Voting

Individuals who wish to vote for the Contest will be required to follow the directions on the Site in order to place a vote. Each voter may vote once per Category (five votes total). The Goldhirsh Foundation and GOOD may share with other Contest Entities or organizations involved with the Contest the e-mail addresses and user information of individuals who vote in the Contest. If the Goldhirsh Foundation and GOOD determines, in their sole and absolute discretion, that any Participant or voter has not complied with these Official Rules in any way, then the Goldhirsh Foundation and GOOD reserves the right to disqualify any Application(s) or vote(s) that such Participant or voter has submitted and disallow any further participation or voting by such Participant or voter in the Contest.

10. Winner Selection

After the Voting Period has ended, the Goldhirsh Foundation (the "Judges"), in their sole and absolute discretion, will select one (1) Application from the ten (10) Applications which receive the most valid online votes in their respective Category to be Winners based on evaluations of the Applications. Five (5) additional Applications will be selected by the Judges based on evaluations of the Applications (one per Category). There will be ten (10) grants total. If there is a tie among the Applications after the Voting Period has ended, the Goldhirsh Foundation and GOOD, in their sole and absolute discretion, will review the tied Applications and will break the tie based on the Application that first in time received the highest number of votes during the Voting Period.

The Goldhirsh Foundation may use any information, whether or not provided in the Applications, to select the Winners, and the Goldhirsh Foundation's decisions regarding Winner selection shall be based solely on the Goldhirsh Foundation's discretion.

It is possible that two (2) or more Participants will submit Applications that may contain the same or similar ideas. GOOD and the Goldhirsh Foundation are under no obligation to review or consider the similarity of other Applications in determining whether or not to accept an Application or in determining the Winner. The Goldhirsh Foundation and GOOD's decisions, in their sole and absolute discretion, are final and binding in all matters relating to the Contest.

The Goldhirsh Foundation and GOOD will require a Winner to complete winner documents as described in Section 11, such as a grant agreement ("Grant Agreement"), as a condition to receiving any Grant and to avoid disqualification as a Winner. No substitution of a Grant is offered, except at the sole and absolute discretion of the Goldhirsh Foundation or GOOD. Any Grant is non-transferable. Neither Goldhirsh Foundation, GOOD nor any other Contest Entity is responsible for a lost or stolen Grant.

11. Taxes

There may be some tax implications for the Winner(s). The Goldhirsh Foundation and GOOD recommend that Participants review their Application with their legal/tax advisor to determine their potential tax liability, if any, in connection with receiving a Grant as part of the Contest. If there is any tax liability, it will be the sole responsibility of the Winner(s).

12. Grant of Rights to GOOD and Goldhirsh Foundation

Submission of an Application constitutes Participant's certification that the Application is Participant's own original work and Participant represents and warrants that the Application does not and will not infringe the intellectual property or proprietary rights of any third party, including, without limitation, any third-party patents, copyrights, or trademarks. By submitting an Application, Participant hereby irrevocably grants each of GOOD, the Goldhirsh Foundation, and their respective successors and assigns an irrevocable, perpetual, worldwide, non-exclusive, royalty-free, sub-licensable (through multiple tiers), and transferable license and right to use, copy, transmit, or otherwise distribute, perform, modify, create derivative works based upon, incorporate into other works, publicly perform, and display the Application or any portion thereof, in or through any medium, whether now known or hereafter created. Nothing herein will constitute an employment, joint venture, or partnership relationship between Participant and GOOD or the Goldhirsh Foundation. Participant also irrevocably grants each of GOOD, the Goldhirsh Foundation, and their respective successors and assigns, where not prohibited by law, an irrevocable, perpetual, worldwide, non-exclusive, royalty-free, sub-licensable (through multiple tiers), and transferable license and right to use the name, voice, likeness, and biographical material of Participant or (if Participant is a group or organization) members of Participant, in any merchandising, advertising, marketing, promotion, press releases, social media, or any other purpose related to the Application and/or Contest or in any other way the Goldhirsh Foundation, GOOD or any other Contest Entity deems appropriate. The Goldhirsh Foundation may also request an in-person appearance at the LA2050 forum by a representative of Participant. Participant acknowledges that Participant has no right of approval or consultation with respect to the Goldhirsh Foundation, GOOD or any other Contest Entity's use of the Application or the licenses and rights granted above.

13. Winner Documents

After the Finalist Period, the Goldhirsh Foundation and GOOD will request from a Winner the following items, each with the form and substance to be determined by the Goldhirsh Foundation and GOOD in their sole and absolute discretion:

1. Grant Agreement for any Grant, in which the Winner will agree, among other conditions, that use of the Grant will be in compliance with all applicable laws and regulations;
2. Details about any proposed project activities, including a project plan; and
3. An Affidavit and Winner Agreement confirming a Winner's eligibility and adherence to these Official Rules.

The Goldhirsh Foundation and GOOD, in their sole and absolute discretion, may request additional information other than as provided above in accordance with its standard practices and policies. The Goldhirsh Foundation or GOOD will notify the Winner(s) by e-mail. Upon e-mail notification, the Winner(s) will provide to the Goldhirsh Foundation or GOOD within three (3) days their address(es) and any other information requested by the Goldhirsh Foundation and GOOD. The Goldhirsh Foundation and GOOD may require a Winner within fourteen (14) days to complete, sign, and return any of the documents listed above, which will be sent to the address(es) provided by the Winner or by email. If a Winner is under the age of majority in his or her state of residence, the Goldhirsh Foundation and GOOD may require the Winner's parent or guardian to sign and return the documents listed above and other documents related to the Contest.

If a Winner (or a Winner's parent or guardian, as applicable) is unwilling or unable to sign and return any document listed above within the specified time period, to provide any item set forth in any document listed above within the specified time period, or to otherwise timely comply with these Official Rules, then the Goldhirsh Foundation and GOOD may void that Winner's eligibility as a Winner (with such Winner forfeiting any Grant). In such case, the Goldhirsh Foundation and GOOD will not have any further obligation to that Winner or to otherwise award any Grant, but the Goldhirsh Foundation and GOOD may, in its sole and absolute discretion, choose an alternate Winner using the same selection method as used to select the forfeited Winner.

14. General Conditions

In the event of a dispute regarding who submitted an Application, the Application will be deemed submitted by the authorized account holder of the e-mail account specified in the Application. "Authorized account holder" is defined as the natural person who is assigned to an e-mail address by an Internet access provider, online service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. It is the sole responsibility of the Participant to notify the Goldhirsh Foundation or GOOD in writing if the Participant changes his or her e-mail or postal address during the Contest Period.

By entering the Contest, Participants agree to be bound by these Official Rules. GOOD and the Goldhirsh Foundation are not responsible for (i) late, lost, delayed, damaged, postage-due, incomplete, illegible, misdirected, or undeliverable Applications, responses, or other correspondence, whether by e-mail, postal mail, or otherwise; (ii) theft, destruction, unauthorized access to, or alterations of Applications; or (iii) phone, electrical, network, computer, hardware, software program, or transmission malfunctions, failures, or difficulties.
